

COUNTRY WEDDING CARS

RENTAL AGREEMENT TERMS

This Hire Agreement consists of the terms and conditions listed below, and is for the hire of the Car described with driver and includes all parts of the Cars, fixtures, fittings, equipment and accessories. The agreement is between "Country Wedding Cars" and you, the hirer. The hirer agrees to all the terms and conditions within the printed agreement.

You are asked to keep this Agreement with your party at all times as proof of your right of hire of the said vehicle and driver.

TERMS OF PAYMENT

A 20% deposit is required with confirmation of booking. Full payment is required before the commencement of hire, with the outstanding balance being paid by cheque/cash at least 14 days prior to the date of hire.

LOSS OR DAMAGE

You are liable for any loss or damage to the vehicle's contents, whether due to theft, vandalism or any other causes during the hire period. A £50 damage excess fee is payable. This will be refunded at the end of the hire. Any costs incurred by the company to repair said loss or damage may result in loss of retained fee.

SMOKING

Smoking is not permitted within the Cars

ALCOHOL

Alcohol supplied as arranged at the time of booking is for consumption only within the cars and not to be taken when leaving the car. The company reserves the right to refuse consumption of alcohol within the cars.

Please note that a £50 Valeting fee will be incurred immediately to any party where a member is physically ill within the Car.

FOOD

The consumption of food is not permitted within the Car.

CONTROLLED SUBSTANCES

Under no circumstances is the use/possession of controlled/illegal substances allowed within the Car.

ADDITIONAL HIRE

Additional journey or hire not arranged at the time of booking will be charged at an hourly rate of part thereof, subject to availability, and at the discretion of the company.

CANCELLATION

In the event of cancellation by the hirer in any circumstances, deposits are non-refundable.

If the hirer cancels the agreement without a reasonable amount of notice then the hirer may be liable for the full amount of the agreement.

BREAKDOWN

We cannot be held responsible for any mechanical breakdown. However, in such circumstances that the car and driver are unable to make the time and day of the agreement due to mechanical fault, the company will endeavour to replace such Car with a like Car or alternative, whichever is available. Failure to do so will result in a full refund of deposit monies paid, thus ending "COUNTRY WEDDING CARS" liability.

DELAYS

The company will not accept liability for delays in journey time due to road/traffic conditions, but will endeavour to make good the journey to the best of their capability.

PROPERTY

The company does not accept responsibility for any items left unattended in the Car.

SEATBELTS

Seatbelts should be worn at all times. Country Wedding Cars cannot be held responsible for any accident or injury if you do not wear the seat belts provided.

TERMINATION

The company reserves the right to terminate the hirer's agreement at any time, before or during the agreement, if the company decides that the hirer is not abiding by the conditions laid out in the agreement or for any other unreasonable behaviour. In these circumstances the company also reserves the right to refuse carriage and to retain monies paid.
